Proof of In-district Priority Status (2 proofs of residency required for OVSD residency status *if admitted*): For purposes of determining eligibility for this enrollment priority status, a student will be considered "in-district" if all of the following apply:

- the student's primary residence as of the date of their application AND as of the date of their submission of their completed enrollment packet lies within OVSD;
- the in-district residence has been the student's primary residence for at least one month prior to the admission lottery, or the family otherwise demonstrates an intention to continue long-term residency within OVSD (See "Special Cases" below); and
- the student's family provides proof of residency by providing the school with **two of the following documents**:
 - 1. Current year property tax statement or current rental agreement with landlord contact information (tax or rental amounts, or other monies due, may be obscured)

- 2. Current pay stub or bank statement showing activity within previous 30 days (financial figures and other confidential information may be obscured, but address must be apparent)
- 3. Original and complete SCE or other utility statement within last 30 days
- 4. Major credit card statement (figures may be obscured, but address must be apparent) showing activity within previous 30 days

Special Cases:

Applicants to the school who believe that they qualify for in-district enrollment preference but whose circumstances do not conform with the bullet points enumerated above should submit a detailed explanation in writing, including relevant supporting documentation, to the school well in advance of the application deadline. Determination of in-district status in special cases will require written approval of the Executive Director.

Proof of residency is not required for homeless students in accordance with the McKinney-Vento Homeless Assistance Act of 1987 and Education Code Section 48850.

IMPORTANT NOTES:

- If your child is offered admission to school, you will be required at the time of the completion of the enrollment package to confirm his or her eligibility for any enrollment priority status claimed on this application.
- If there is a change in your child's priority status before the time of the lottery, or post-lottery while on the waitlist, it is the applicant's responsibility to notify the school of that change.
- If an applicant's status has changed and the school is not informed and you are unable to provide proof of the priority status stated on this application at the time of turning in the enrollment package, then the student will forfeit his/her place and will go to the end of the waitlist.
- Offers of admission will be made by electronic and postal letter to the applicant's family, to be sent within ten (10) days of the enrollment lottery. The family will have five (5) business days from the date of mailing to respond. If the family does not respond, one phone call will be made, and the family has two (2) business days to contact the school. If the family still does not respond, the applicant will be considered to have "declined" and will lose his/her place in the class.

State Vaccination Requirements for Enrollment:

Students who are (1) entering Kindergarten for the first time, (2) entering 7th Grade, (3) transferring from out-of-state, or (4) who do not already have a medical exemption (ME) on file with a California school will be required to meet the CDPH Immunization Requirements for their age. Community through Diversity, Equity, and Inclusiveness

- 4) volunteer at the school, with the goal being a minimum of 5 hours per month on average
- 5) work together with teachers, administration, and other parents to solve concerns to help our diverse and inclusive environment flourish.
